

## APPENDIX F PRICING STRUCTURES

The Principal Investigator may use CAMRI's fMRI scanners for any research project for which he/she has IRB approval after he/she signs Appendix I and selects one of the following pricing structures, which must be paid by the Principal Investigator within 30 days of receipt of invoice from the CAMRI. The annual rates above are based on a July 1 – June 30 year (BCM fiscal year). Any contracts signed that cross fiscal year will be invoice at a pro-rated amount. For example, a contract signed on March 1 will be invoiced for 4 months in March and the remaining 8 months in July. All scan time purchased under this contract will expire 12 months from effective date. Unfortunately, it is not possible to transfer unused scanner time to other investigators or carry it over into future fiscal years

- A. \_\_\_ **Standard Hourly Rate** of \$500 per hour of use of MRI Scanners, with appropriate scheduling of time on machines, which will be invoiced on a quarterly basis in arrears.
- B. \_\_\_ **Package A** - annual rate of \$10,000, which includes 21 hours use of the MRI Scanners with appropriate advance scheduling (equates to \$475 per hour).
- C. \_\_\_ **Package B** - annual rate of \$20,000, which includes 44 hours use of the MRI Scanners with appropriate advance scheduling (equates to \$450 per hour).
- D. \_\_\_ **Package C** - annual rate of \$35,000, which includes 82 hours use of the MRI Scanners with appropriate advance scheduling (equates to \$425 per hour).
- E. \_\_\_ **Package D** - annual rate of \$50,000, which includes 125 hours use of the MRI Scanners with appropriate advance scheduling (equates to \$400 per hour).
- F. \_\_\_ **Package E** - annual rate of \$75,000, which includes 200 hours use of the MRI Scanners with appropriate advance scheduling (equates to \$375 per hour).
- G. \_\_\_ **Package F** - annual rate of \$125,000, which includes 350 hours use of the MRI Scanners with appropriate advance scheduling (equates to \$357 per hour).
- H. \_\_\_ **Package G** – annual rate of \$250,000, which includes unlimited use of the MRI Scanners with appropriate advance scheduling, with a maximum of 12 hours per day.
- I. \_\_\_ **Technical Rates** – hourly technical fees of \$100 per hour, with a 1 hour minimum.

Additional hours in excess of those included in the Packages A-F will be charged at the Standard Hourly Rate, or the Principal Investigator must purchase an additional package (maximum of one additional package per year); however, on a one-time annual basis, a Principal Investigator may elect to increase his/her current package by 10% of the package hours at the package hourly rate (within the 12 month contract term). For example, a Principal Investigator who selects Package D and uses all 125 hours in a given year may notify the CAMRI that he/she wishes to purchase 12.5 additional hours at a rate of \$400 per hour.
