Pedagogy of the course:

The objective of this paper is to acquaint the students with the diversity of British literature from the early 20th century. The course is designed around original texts, exploring a multitude of thematic formulations.

For the course 80 percent will be Class room teaching and 20 percent will be Internal Assessment comprising Unit test, Assignments and class room participation. The evaluation method for this course will be 20 percent Internal Assessment, 20 percent Multiple Choice questions Test, and 60 percent End semester examination.

Instructions for Paper Setters:

The end semester examination will be of 3 hours and 60 marks. There shall be 9 questions in all. The first question, which would be compulsory, shall be short answer type (word limit 125 each), preferably from the Key Terms. It would carry 06 short questions, spread over the whole syllabus. The candidate will be required to attempt all short answer type questions. Each short answer type question would carry two marks (2x6 = 12). Rest of the paper shall contain 4 units. Each unit shall have two questions and the candidates shall be required to *attempt one question* from each Unit (four in all). Each question shall carry 12 marks (12x4 = 48).

Course Title: British Literature: 17th & 18th Centuries Course Code: ENG05C203

Credit: L-T-P: 5-1-0

Total Credit Hours: 60

Pedagogy of the course: This paper deals with the development of English literature during the English Literature during the Elizabethan and post-Elizabethan period, viz., after Shakespeare and Marlowe. This paper will acquaint the students with major literary works, different literary genres, major authors and basic literary theory and criticism from the Age of Milton to the beginnings of Romanticism with special focus on Restoration and Renaissance Literature.

For the course 80 percent will be Class room teaching and 20 percent will be Internal Assessment comprising Unit test, Assignments and class room participation. The evaluation method for this course will be 20 percent Internal Assessment, 20 percent Multiple Choice questions Test, and 60 percent End semester examination.

Instructions for Paper Setters:

The end semester examination will be of 3 hours and 60 marks. There shall be 9 questions in all. The first question, **which would be compulsory**, shall be short answer type (word limit 125 each). This paper seeks to give the students a sense of how the great American themes of self-reliance, individualism, sin and redemption and multiculturalism were shaped through its rich and varied Literature. Genesis and evolution, and the defining myths of American Literature—city on a hill, the frontier spirit, the American Dream, manifest destiny.

Pedagogy of the course:

The main objective of this project is to inculcate among the students, the essential skills of research, the nuances of manipulating important ideas in a logical connected manner, and its consequent documentation. The evaluation of this paper will be based on Presentation of Research work (20%) and Evaluation of Project Report (80%).

Instructions and Evaluation:

No formal teaching would be offered in the department for this course. The theme of the project is chosen at the beginning of the semester after consulting the teacher assigned for the purpose. Before the commencement of end semester exams, students shall submit a project report having pages not less than 40 pages on the research topic. If any student is unable to submit his/her project report within stipulated time then student will be considered as absent from the exam and have to re-appear in the exam as per university policy and regulations. No extensions for the submission of project work will be granted. At the end of the semester, there will be assessment of the presentations by students on their project. In their presentations, students have to explain how they have formulated the problem, on which their project report is based, the reasons for selecting the topic, the sources, hypotheses, methods, findings and conclusions. After the presentation, each student shall receive a detailed response from the teachers. The class as a whole then offers feedback, suggestions for new angles and methods, and comparative insights into links with other topics.

a) Criteria for internal assessment for presentation

The assessment committee of the department will evaluate the presentation of the students using the following criteria:

The project report shall be evaluated by ONE external examiner. The examiner shall evaluate the report on the basis of following criteria. External examiner shall be appointed as per University rules and regulations. The project report shall be written in English language only to develop the writing and research skills of the students except for the language departments. The following criteria and percentage weightings are to be taken into consideration by the examiners while assessing the report:

- a) Explanation, contextualization and articulation of research problem and objectives (12.5%, Marks=10) :
- ☐ Is the research problem clearly specified and contextualized?
 - ☐ Are the research questions and hypotheses clearly formulated?
 - ☐ Does the report capture the relevance, rationale and objectives of the proposed research topic?

- b) Literature and/or technology review, as relevant (25%, Marks:20):
- ☐ Does the report include a comprehensive review and critical discussion of the relevant literature and/or technological developments?
 - ☐ Is there any description on how the proposed research positions itself within the generic context of works which have been published in the area?

- c) Methodology, design and implementation (25%, Marks:20):
- ☐ Is the adopted methodology and/or design approach clearly justified?
 - ☐ Is the implementation of methodology and design well explained?
 - ☐ Have any novel theoretical contributions from the student been rewarded appropriately?
